

Goals of TURA

50% reduction in the generation of toxic by-products by 1997 through TUR (achieved = 47%; 50% by 1999; now >60%)

Establish TUR as the preferred means of regulatory compliance

Sustain and promote the competitive position of Massachusetts industry

Promote reduction in the production and use of toxic and hazardous substances

Enhance and strengthen enforcement of environmental laws, and coordinate state agencies administering toxics-related programs

As planners, you can do more than simply satisfy regulatory goals

Elevate importance of EH&S

- Go beyond compliance
- Increase operator to senior management buy-in

Identify waste reduction and cost savings

- Increase profitability
- Demonstrate value of EH&S

Promote sustainability

- Create safer work environment
- Stay ahead of customer and global market restrictions

Pre-Planning is the foundation of your efforts

- Facility-Wide Information Requirements (310 CMR 50.43)
- TURA requires that a certified TUR plan include:
 - A statement of facility-wide policy regarding TUR
 - A statement of the scope of the plan
 - **Expected** change in facility-wide use and byproduct generation for each covered toxic

Scope: Facility-Wide Level

Description of each production unit, including:

- Production unit number
- Process description(s)
- Product
- Unit of product
- Chemicals and CAS numbers from each covered toxic associated with the production unit

Description of the process for identifying TUR options

Summary of all TUR techniques that were considered appropriate

Management Policy

Purpose

- Focus attention on encouraging (or discouraging) TUR
- Communicate (internally and externally) firm's commitment to TUR

Must include

- How facility encourages TUR
- Policies that encourage/discourage TUR

Optional policy information

- Role of TUR in hiring, salaries, promotions
- R&D and TUR
- Capital investment decision process

DEP observations

- Policies that encourage or discourage TUR often missing
- Optional information rarely present

Employee Notification

Must happen by January 1 of planning (even-numbered) years

Must:

Identify and describe production units

Explain planning criteria/requirements

Solicit TUR suggestions

Describe how your facility does this within your TUR Plan

DEP

observations:

Not always done in timely fashion

Often missing planning criteria

Simply posting on a bulletin board seems to garner few results




